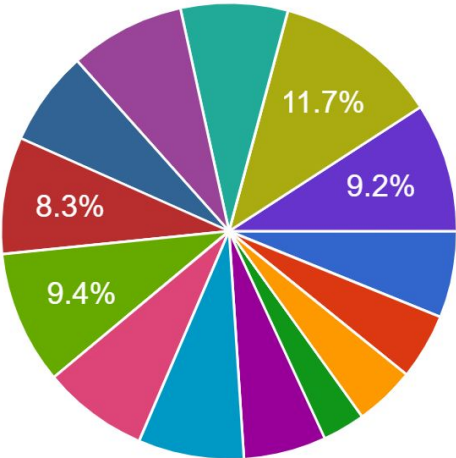

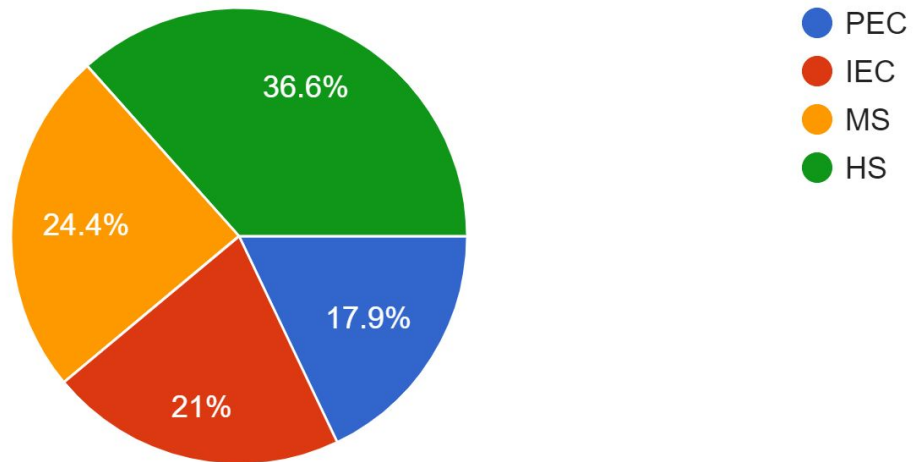

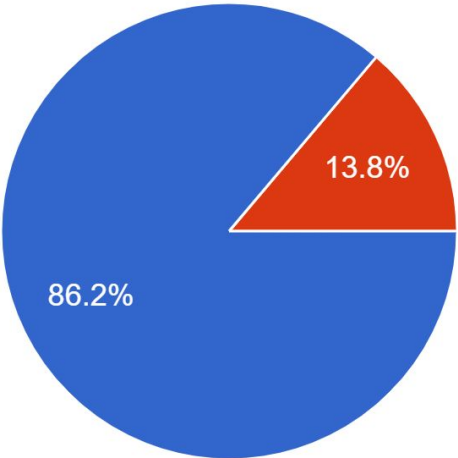
Which school does your child attend?

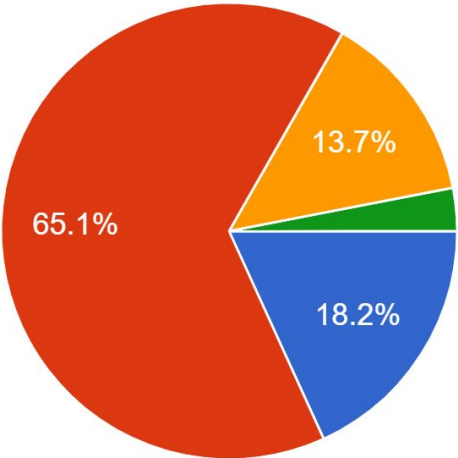

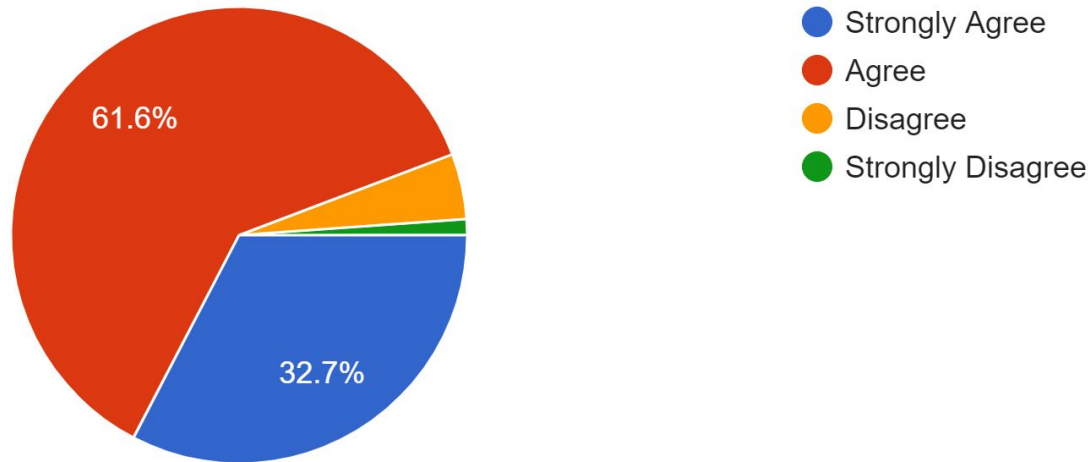

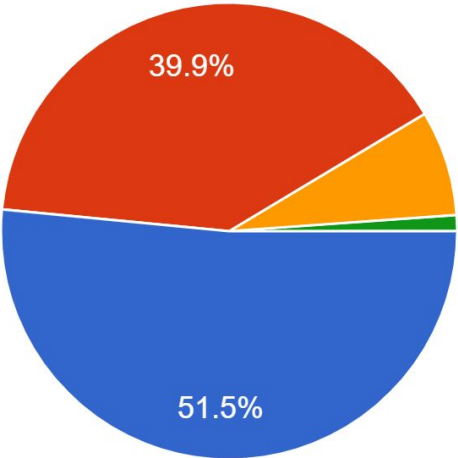

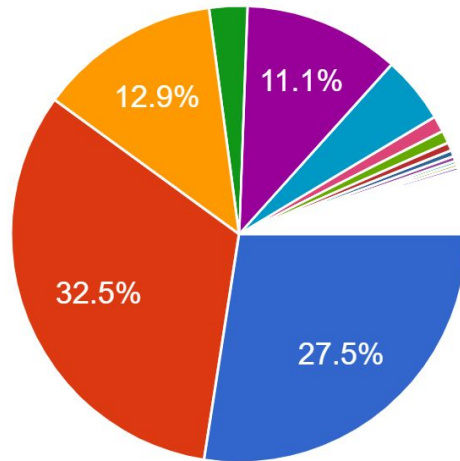

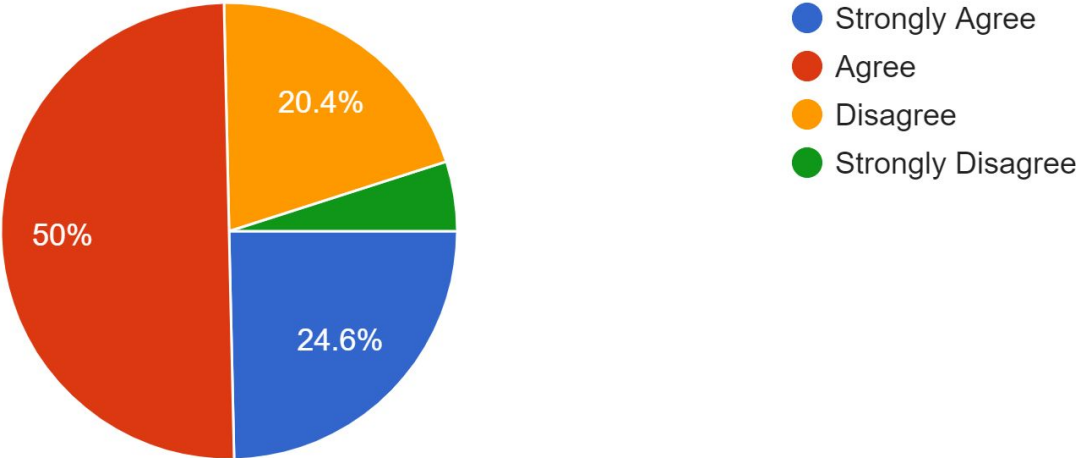

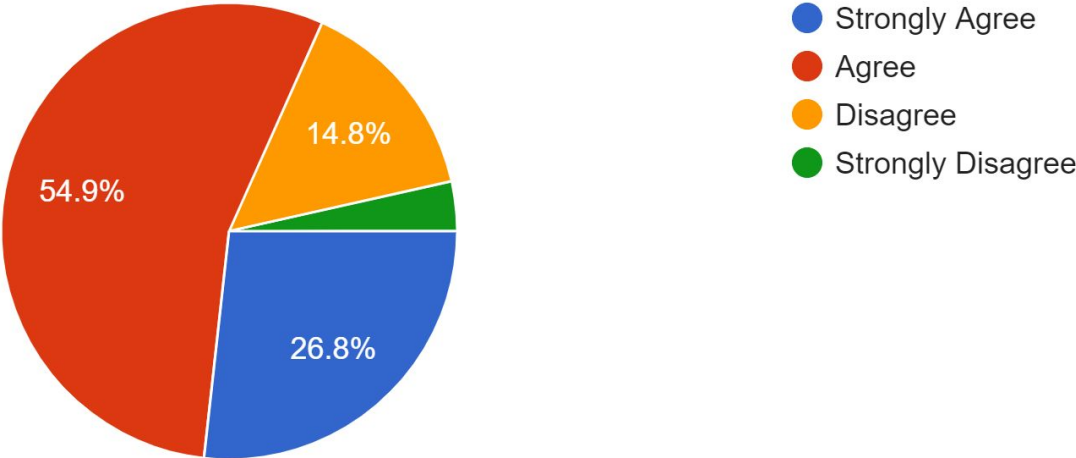
The remote synchronous learning experiences keep my child engaged in the learning process.

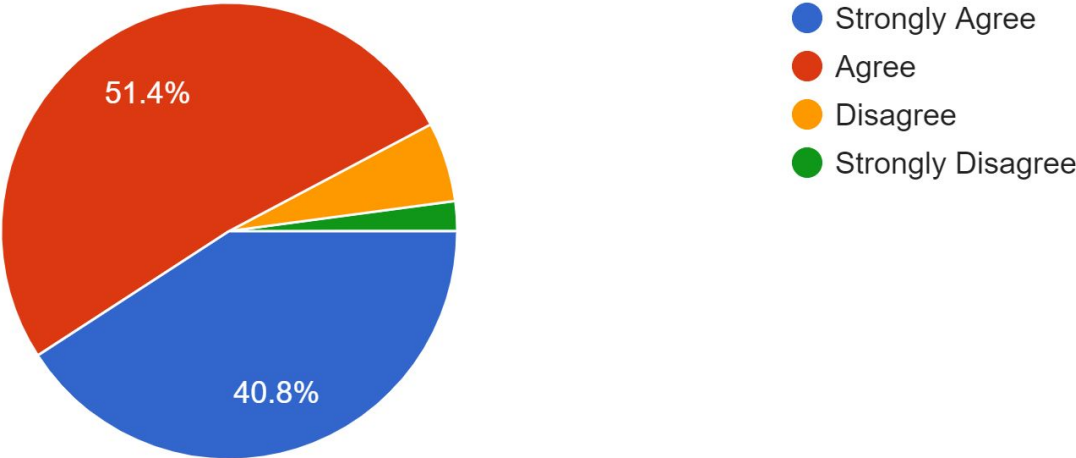

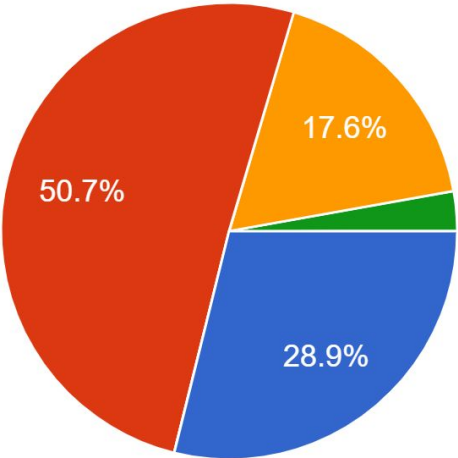

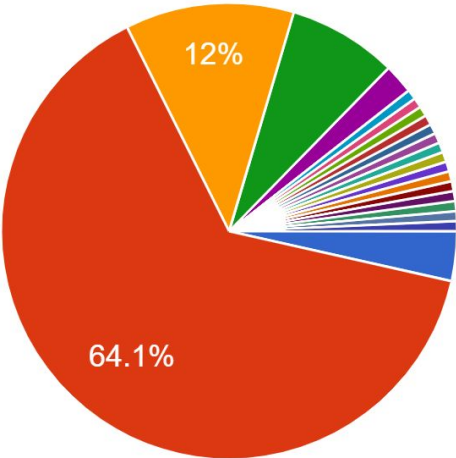

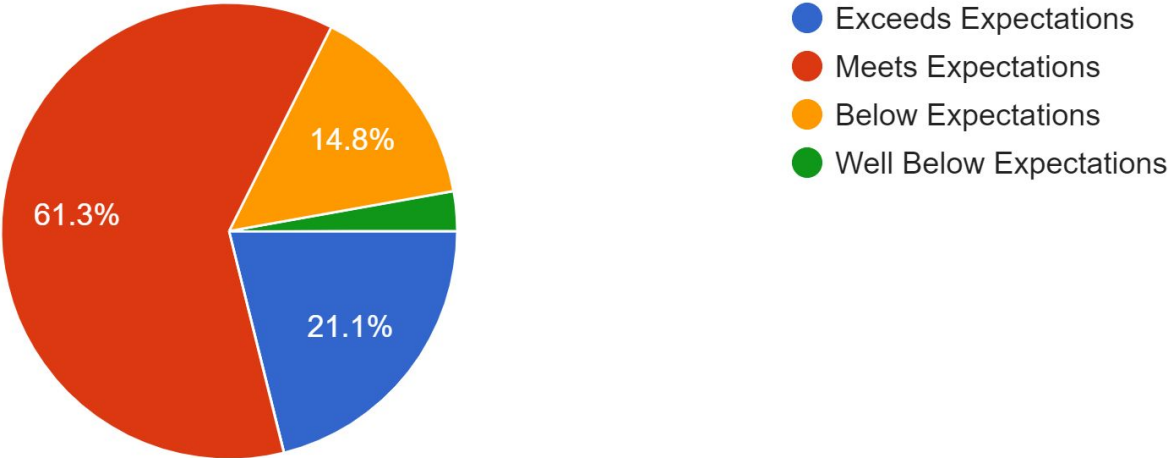

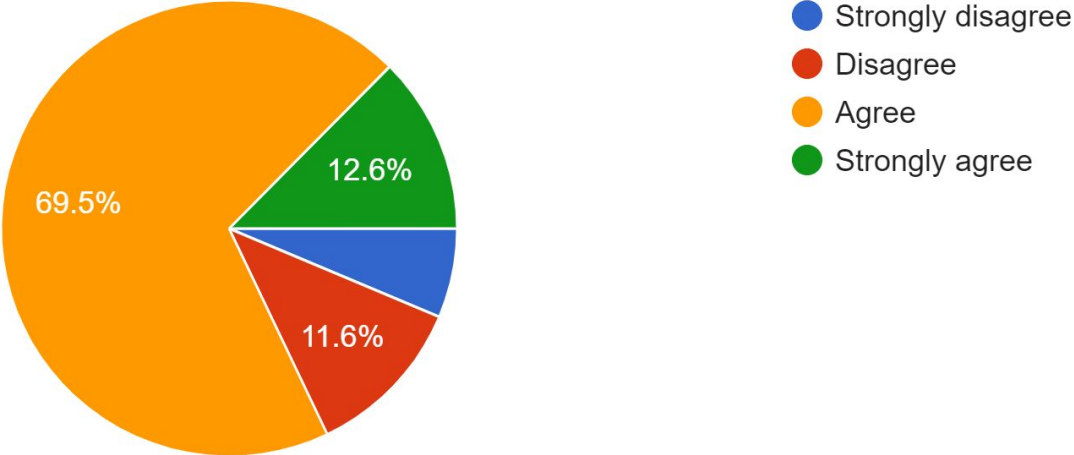

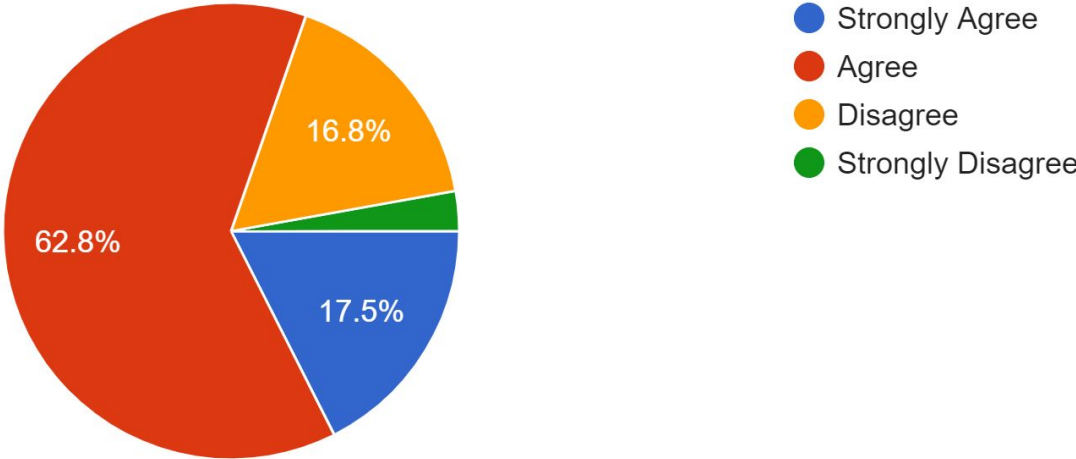

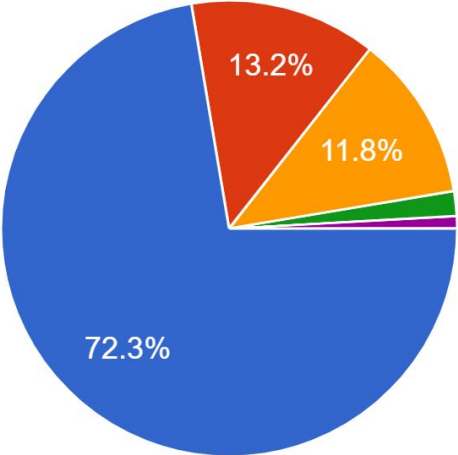

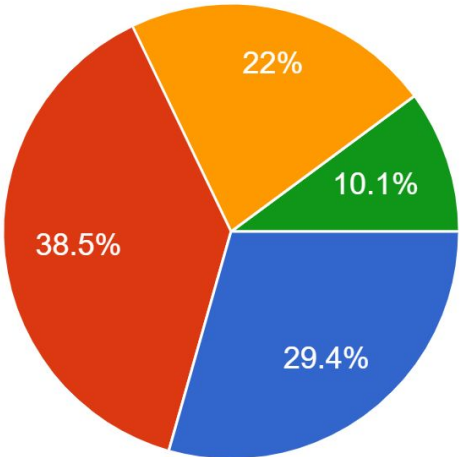

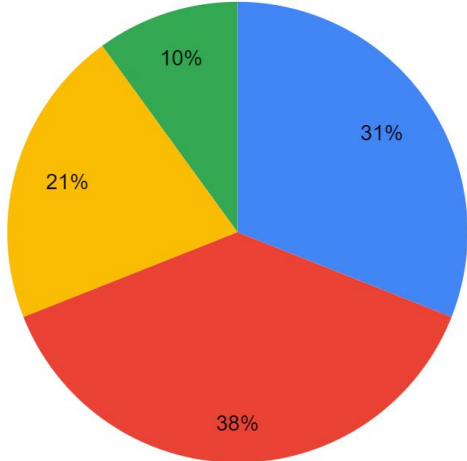
