Comprehensive Counseling Program:

- Develop, implement, and evaluate a comprehensive school counseling program using the four components of the ASCA National Model: Define, Manage, Deliver, and Assess.
- Conduct classroom lessons addressing academic skills, social-emotional learning, bullying prevention, conflict resolution, and character development, aligned with ASCA Mindsets & Behaviors standards.
- Facilitate individual and small-group counseling sessions based on identified student needs related to academic success, social-emotional development, and career awareness.

Collaboration and Consultation:

- Collaborate with teachers, administrators, families, and external support services to create supportive environments that enhance student success.
- Advocate for student needs and equity, ensuring that barriers to learning and development are addressed.
- Consult with school staff and families to implement effective strategies promoting academic achievement, positive behavior, and emotional health.

Crisis Intervention and Prevention:

- Implement effective de-escalation strategies aligned with best practices in crisis intervention.
- Support students experiencing crises by providing immediate response, intervention strategies, and follow-up actions.
- Apply Therapeutic Crisis Intervention (TCI) methodologies if trained or commit to acquiring this training to effectively manage severe behavioral incidents.

Restorative Practices and Anti-Bullying Efforts:

- Lead school-wide initiatives to implement restorative practices emphasizing empathy, accountability, and positive relationship-building.
- Provide anti-bullying education and interventions, supporting the creation of a respectful and inclusive school climate.
- Coordinate comprehensive anti-bullying programs addressing prevention, intervention, and response strategies.

Elementary Launch Lab Coordination:

- Manage and coordinate the Elementary Launch Lab, an in-school suspension alternative, on an as-needed basis.
- Supervise students assigned to the Launch Lab, implementing structured behavior interventions, reflective exercises, academic assistance, and restorative practices.
- Document interventions, monitor student progress, and communicate regularly with parents, teachers, and administrators regarding student improvement and outcomes.

- Regularly evaluate the effectiveness of counseling interventions and programs using datainformed practices recommended by the ASCA National Model.
- Maintain accurate and detailed records and documentation consistent with district requirements and ASCA standards.
