## Award: \$750, Due Date: April 15, 2024

*The Lewiston Porter Federal Credit Union sponsors this annual scholarship as an opportunity for our members. This scholarship seeks to acknowledge outstanding academic achievement and provides financial support for future educational goals.*

### Guidelines:

- Applicant must be a member **in good standing** of the Credit Union. **There is no age requirement or limitation.**
- Applicant must be enrolled full time (12 credit hours or more) in an accredited post-secondary collegiate or vocational/technical program.
- A scholarship award may be renewed for **\$750.00 annually for up to three additional years.** Scholarship recipients must obtain a 3.0 GPA or equivalent for continued renewal. Failure to maintain required GPA will result in disqualification for any remaining scholarship awards.

### Requirements:

- Applications may be obtained from the Credit Union Office located in the Lewiston-Porter District Office or there are copies in the Guidance Office.

# DONNA PARENT LEWISTON PORTER FEDERAL CREDIT UNION SCHOLARSHIP

The Donna Parent Lewiston Porter Federal Credit Union is a scholarship opportunity for members of the Lewiston Porter Federal Credit Union. This scholarship seeks to acknowledge outstanding academic achievement, and provide financial support for future education goals.

1. One **\$750.00 Credit Union scholarship** will be awarded each year. Additionally, **this scholarship may be renewed for \$750.00 annually for up to three additional years.** Recipients must obtain a 3.0 GPA or equivalent for continued renewal. Failure to maintain required GPA will result in disqualification for the remaining scholarship awards.
2. The scholarship is available to **members in good standing of the Credit Union.** **There is no age requirement or limitation.** Students must be enrolled full-time (12 credit hours or more) in an accredited post-secondary collegiate or vocational/technical program.
3. Applications may be obtained from the Credit Union office beginning January 1, 2024. **The deadline for the applications is April 15th, 2024.** Applications will be anonymously reviewed by the Scholarship Committee, and recommended for approval by the Credit Union Board of Trustees. The winner will be notified by May 10<sup>th</sup>, 2024.
