

2021-22 Budget Message from the Board of Education and Superintendent

Who could have imagined a school year such as this one in the Era of COVID-19? Beginning in March of last year, the Lewiston-Porter School District and community have faced unprecedented challenges. Never before has the partnership between school, home and community been more clear, or more important. We cannot thank you enough for your support.

Despite many obstacles our schools have remained open the entire year for on campus learning. Across the district, our schools operate in multiple learning models: The hybrid model blends virtual Mondays with in-person/on campus learning two days per week and remote learning two days per week or each student; Daily Lancers (specific Special Education and English Language Learners) are on campus everyday; BOCES Career and Technical Education students are transported daily to the Sanborn CTE Center; and 100% Remote Learners are provided online education in a guided synchronous/asynchronous (Elementary) and asynchronous (Secondary) model everyday, progressing at their own pace. Our teachers, staff and administrators have worked tirelessly to provide teaching and learning, academic and emotional support to students who at any point of any given day may be on campus, on line, or at home.

Slowly, incrementally we are making progress. Currently, Elementary students are now back on campus everyday: At the end of April, working within updated State and Federal guidance, we were able to welcome PreK-5 students back to a full five days of instruction. Students at the Middle and High Schools remain in the hybrid model, due to social distancing restrictions in Niagara County in accordance with our current transmission rate determination by the CDC. All students wishing to remain in the 100% remote model remain at home, with two distinct (Elementary and Secondary)

remote education programs and staff. If this sounds complicated, it is.

The cost of the pandemic cannot be underestimated. Increased operating expenses have been part and parcel to keeping our schools open and our students, faculty, staff, and community safe: The cost of protective equipment (PPE), air quality supplies, barriers, and additional desks; Added cleaning staff and hours, along with sanitizing and disinfecting supplies; Technology, including the cost of the remote learning program and its additional staffing requirements. Careful budgeting, as we headed into this difficult year, together with our strong academic and financial position, allowed us weather the uncertainty and turmoil.

In the midst of this crisis, we respectfully present the proposed 2021-22 budget of \$51,195,913 to the residents and taxpayers of the Lewiston-Porter Central School District. This represents a 4.28% increase budget-to-budget, and a 1% increase to the tax levy. While it is still with great uncertainty that we look to next year, we know that progress is being made toward full and complete reopening in the 2021-22 school year. Our balanced budget takes current numbers and all potential impacts into consideration. It plans for a traditional school year, with anticipated increases in needs for academic and emotional support, and consideration for continued necessity to work within pandemic guidelines and precautions. The proposed budget is the result of significant work and planning by the District leadership team in collaboration with the Board of Education. The District Strategic Plan continues to set the direction of all fiscal decisionmaking, together with our long-term financial

We are grateful to the State and Federal governments for the significant support realized

this year to balance the incredible

financial burdens of operating during a global pandemic. The finalized state budget includes a 2.97% increase in Foundation Aid. Other aid categories particularly BOCES Aid and Transportation are cost driven aids based on dollars spent in this 2020-21 school year. We know these estimates in our total aid package are high so we must qualify the inclusion of those numbers with our internal estimates of spending this year in both those categories. We know those final aid numbers may be less, so we carefully look to limit spending in these areas.

Federal aid is finally arriving, with significant resources to put directly toward remediation, social-emotional support, technology, and other very specific initiatives over the next three years. There are a lot of strings attached to this aid, but this support brings great opportunity to better the education, health and wellbeing of our children. We are currently in the process of reviewing the parameters of this aid, and will maximize every cent.

While we are appreciative of this year's state and federal aid, we remain cautious and conservative in our fiscal planning. Our district has borne the brunt of State financial crisis before, and we know a strong year can be followed by great volatility. Over the past six years, we have developed careful, conservative fiscal planning and a Strategic Plan focused on student achievement. By closely following our Strategic Plan and long term fiscal planning, spending is focused to fully support educational priorities and a full reopening of school, while remaining fair and responsive to the current and future needs of our taxpayers.

for a full reopening of schools in 2021-22, including continued need for personal protective equipment (PPE), cleaning, disinfecting and air quality supplies, and the possibility of having to run a fully remote learning model into next year. Also included in the budget are potential increases to transportation, contractual obligations for three of the bargaining units, whose contracts will be negotiated this Spring. Beyond that we have continued educational mandates (increases to Special Education, transportation) balanced through strategic and careful programmatic initiatives, and continued healthcare cost containment. Careful budgeting and constant monitoring of expenses to capture efficiencies, and contractual savings due to the closure allowed for budgetary savings in 2020-21. Those savings have been applied within this budget along with careful appropriation of hard-earned reserves, along with a modest increase of 1% to the tax levy, well below both CPI and the tax cap threshold.

The Budget Vote and Board of Education Election will take place on Tuesday, May 18, 2021 from 7:00am to 8:00pm in the Community Resource Center, Multi-Purpose Room. Anne was elected to the Board of Education in 2019. She dove into her work on the board immediately, joking at her second meeting that she was only ¾ of the way

through the 1000+ page School Law book. She voraciously read that law book, the policy manual, and everything she could get her hands on. She served on both the Facilities and Policy Review Committees, stepping up to chair Policy Committee in 2020. She was posthumously presented the New York State School Board Association Board Achievement Award on April 26.

Her service to the community extended beyond the Board of Education, to numerous charitable and political organizations. She served as Chair of the Niagara Area Foundation Council, as a sous chef for Meals on Wheels, and tirelessly worked on political campaigns,

including being a founding member of Indivisible Niagara, a political action group. During the past year of the pandemic, she worked tirelessly delivering meals to those in need and made thousands of cloth masks, which she distributed freely throughout the district and across the country.





Six Students Inducted Into National Technical Honor Society

Congratulations to the six Lew-Port High School students from the Niagara Career and Technical Education Center who were recently inducted into the National Technical Honor Society.

Isabella Aquino (Cosmetology), Angelina Giammarinaro (Cosmetology), Jeffrey Hayhurst (HVAC and Refrigeration), Tateum Hillman (Security & Law Enforcement), Kaci Misterkiewicz (Security & Law Enforcement) and Seth Robinson (Animation, Film and Visual Effects) were recognized for their achievement.

Out of all the high school students in the United States, the National Technical Honor Society students who receive this honor comprise 1.6 percent of that population. For staff at the Orleans/Niagara BOCES center, they represent the four pillars of the National Technical Honor Society: Scholarship, leadership, service and character.

The students had to maintain an 89.5 grade average in their career and technical education programs and an 84.5 average at their high schools, have superior attendance, exemplary behavior, be a member in good standing with SkillsUSA and have a recommendation from a faculty member.



PEC Students Advance to Robotics Invitational

Students in Mrs. Kazulak's second grade enrichment group studied coding and then entered the Wonder League Robotics Competition (WLRC). That good decision, landed the team into the invitational final round.

Kazulak said, "The competition involved the team working their way through five separate "missions" and then submitting their work to a team of WLRC judges. Points were awarded based on the code itself as well as set design and originality. This group of students made it through all five challenges and were invited to participate in the invitational." At the finals, teammates Lauren Toohey, Ella Wedge, Amelia Sachs, and Noah Rookey received an honorable mention for most collaborative collaborators.

"A total of 196 teams from across the globe made it to the finals. We were one of them, and although we did not get the top five, honorable mention is awesome for a group of students who had never coded before!" Kazulak added, "It has been a challenge getting the team together due to our limited time in school. However, perseverance by these students and their families has made it possible."

The Wonder League Robotics Competition started in 2015 and has now reached more than 86,500 students from across the globe over the last five years. This competition has inspired an early love of coding, computer science, tangible learning, and STEAM education. Through a series of story-based missions, the teams develop problem-solving,

growth mindset, creativity, cooperation, collaboration and perseverance.


