

# 2023-24 Budget Message from the Board of Education and Superintendent of Schools

Since March 2020, the Lewiston-Porter Central School District and school community have faced unprecedented challenges. Throughout this time our keen focus has been on the success of all students. Our mission statement, "One purpose. Your pathway. Our promise" is focused on our students and their individual success. Students are with us for thirteen of the most important and formative years of their lives. We recognize the responsibility we have for each and every child and family. Our success is their success.

Our teachers, staff, and administrators work tirelessly to provide academic and emotional support to our students. We continue to see challenges, particularly with student social-emotional concerns coming out of the pandemic. In response, we have added staff and programming for each building-to provide further support for our students across the campus. We have invested in Restorative Practices training for all staff as an opportunity to support the socialemotional growth of our students at all levels. We continue to focus on our student's mental health and well-being. We are making progress but we also know there is still much more work to do.

The recent inflationary pressures on resources and services needed for school operations cannot be underestimated. Increased operating expenses have been part and parcel of keeping our schools open and our students, faculty, staff, and community safe. Careful budgeting has allowed us to weather the uncertainty and turmoil. Looking year-to-year, the budget we present this year is developed well below the increases seen in the consumer price index.

Factoring in property values and what's called, the "district wealth ratio," state aid dollars

are allocated according to a per-pupil basis. Unfortunately, with declining enrollment at our schools, we are seeing fewer and fewer state aid dollars each year. What's more, those state aid dollars have seen very little increase each year. Despite the massive increases seen in other local school districts, Lewiston-Porter, going back 17 years from when the original state aid formula was created, has always been considered to be an overfunded district due to local property values and local wealth ratio. While other districts have seen millions of dollars in state aid increases every year, Lewiston-Porter for this year saw only \$309,006 in new state aid.

We respectfully present a proposed 2023-24 school budget of \$54,593,312 to the residents and taxpayers of the Lewiston-Porter Central School District. This represents a 2.71% increase in budget-to-budget and a 2.65% increase in the tax levy. Our balanced budget takes current numbers and all potential inflationary impacts for the 2023-24 school year into consideration. The 2023-24 school year plans for continued development of student academic and social-emotional support. The 2023-24 school budget continues to support our award-winning art and music programs, our championship athletic programs, and important community outreach like our very popular community education program. We have also added significant safety measures in all school buildings and for next year we will have two full-time School Resource Officers ensuring safety and security across our campus. The proposed budget is the result of significant work and planning by our leadership team in collaboration with the Board of Education. The District Strategic Plan continues to set the direction of all fiscal decision-making, together with our long-term financial goals.

We are grateful to the State and

Federal governments for the support realized this year. The finalized state budget includes a 3% increase in Foundation Aid or \$309,006 of new state aid. Other aid categories, particularly BOCES Aid and Transportation Aid, are cost-driven aids based on dollars spent in this 2022-23 school year. These dollar amounts are estimates in our total aid package and the inclusion of those aid numbers must be qualified with our internal estimates of spending; adding in inflationary pressures in those areas that may be realized after July 1, 2023

Budget-to-budget increases for the upcoming fiscal year were significantly driven by overall inflationary pressures being felt by all businesses and organizations, especially with natural gas and fuel costs. Also included in the 2023-24 budget are increases to transportation and contractual obligations with the various bargaining units representing our employees. Careful budgeting and constant monitoring of expenses to capture efficiencies and limit the rising cost of healthcare have been incorporated into the budget process. Those savings have been applied within this budget along with the careful appropriation of reserves, along with an increase of 2.65% to the tax levy, still well below the Consumer Price Index (CPI) and the New York State tax cap threshold for individual school districts.

Federal aid in the form of CRSSA (Coronavirus Response and Relief Supplemental Appropriations) and ARP (American Rescue Plan) is beginning to phase out. We will continue to use these important dollars toward academic remediation and intervention, social-emotional support,

The district would eliminate: all equipment purchases, all travel and conferences, Modified sports would be eliminated, three teaching positions, one administrative position, one clerical position and three teacher aides. Additionally, community education and field trips would be eliminated. Finally, supplies and material would be decreased. The proposed budget will be reduced by approximately \$1.1 million to be in compliance with contingency budget requirements.

technology, and other very specific initiatives over this final year. This financial support has brought a great opportunity to better the education, health, and well-being of our students. As these funds expire we will continue to support some of this work in our general fund. A good example of this support is the continuation of math instructional specialists at the PEC, IEC, and Middle School and the Lancer Learning Center Director at the High School. These positions have now been built into the general budget.

While we are appreciative of this year's state and federal aid, we remain cautious and conservative in our fiscal planning. Our district has borne the brunt of the New York State financial crisis before. Over the past seven years, we have developed careful, conservative fiscal planning and a strategic plan focused on student achievement. This year especially we are using a large number of employee retirements to reduce labor costs to the right size in our district. By closely following our strategic plan and long-term fiscal planning, spending is focused on fully

supporting our educational priorities, while remaining fair and responsive to the current and future needs of our taxpayers.

The Budget Vote and Board of Education Election will take place on Tuesday, May 16, 2023, from 7:00 am to 8:00 pm in the Community Resource Center, Multi-Purpose Room. 



I am a participating community member attending Lewiston-Porter District Safety Committee meetings.






### Luminaria Ceremony to be Held

#### Voter Eligibility

To qualify as a voter, a person must be:

- · a citizen of the United States
- at least 18 years old
- a resident of Lewiston-Porter Central School District for at least 30 days prior to the vote. (Education Law § 2012)

No prior registration is required and residents do not have to be registered voters. (Education Law § 2012). But if you are interested in registering to vote for other elections that do require registration, you can register to vote at Niagara County Board of Elections.
